Consolidated worldwide external claims of UK-owned monetary financial institutions (excluding central bank): 2020 Q4

- UK-owned monetary financial institutions and their branches and subsidiaries worldwide reported an increase in consolidated external claims on an ultimate risk basis of \$123.8 billion during 2020 Q4, to a level of \$4,021.6 billion.
- By sector, the largest increase was on the public sector, up \$84.9 billion to a level of \$1,353.4 billion.
- By region, the largest increase in claims was on Developing Countries, up \$69.4 billion to a level of \$805.2 billion.

Chart 1: Changes in external claims on an ultimate risk basis by region and origin of claim





Chart 2: External claims on an ultimate risk basis analysed by country share




Chart 4: Changes in consolidated claims by country

Chart 3: Changes in consolidated claims by counterpart sector








Chart 8: Changes in consolidated claims by country
