# Consolidated worldwide external claims of UK-owned monetary financial institutions


### (excluding central bank): 2021 Q1

- UK-owned monetary financial institutions and their branches and subsidiaries worldwide reported an increase in consolidated external claims on an ultimate risk basis of \$45.6 billion during 2021 Q1, to a level of \$4,064.1 billion.
- By sector, the largest increase was on the public sector, up \$39.1 billion to a level of \$1,391.7 billion. This was partially offset by a decrease on the non-bank private sector, down \$13.9 billion to a level of \$2,107.8 billion.
- By region, the largest increase in claims was on Developed Countries, up \$29.2 billion to a level of \$2,432.3 billion.





Chart 2: External claims on an ultimate risk basis analysed by country share

#### Chart 3: Changes in consolidated claims by counterpart sector




Chart 4: Changes in consolidated claims by country








Chart 8: Changes in consolidated claims by country
